501: SPRINKLER SYSTEMS FOR INDUSTRY PROFESSIONALS

Friday, October 4

This class will satisfy the requirements for the 6 hours continuing education for the fire suppression sprinkler inspectors licensed by the Department of Housing, Buildings and construction in the state of Kentucky. The Class will cover NFPA 25 for the inspection of water based suppression systems. Students should bring NFPA 72, 2010 Edition

502: FIRE ALARM SYSTEMS FOR INDUSTRY PROFESSIONALS

To Be Determined

Thursday, October 3

This class will focus on the requirements and methods for properly inspecting Fire Alarm systems in the State of Kentucky. This class will serve as the required 6 hours of continuing education needed by Kentucky certified fire alarm inspectors and 6 hours needed by Kentucky certified building inspectors. This class will help the student have a deeper understanding of Fire Alarm systems. Classroom discussion will be presented about where they are required, how they are to be maintained, proper inspection of the systems, how they function, and how they can help save a life. Students should bring NFPA 72, 2010 Edition.

One Day Classes

(8 hours each)

101 AIRCRAFT RESCUE AND FIRE FIGHTING

Captain Cliff Cope Sunday, October 6th Maximum Class Size: 15

The Aircraft Rescue and Fire Fighting class is designed to teach the structural firefighter the nuances of aircraft fire fighting and rescues utilizing structural equipment. Most aircraft incidents do not occur on an airfield where access to crash trucks equipped with high flow nozzles and class B foam are readily available. They occur in areas protected by structural departments. This class familiarizes firefighters with knowledge of different aircrafts, passenger loads, jet fuels, general aviation fuels, access to aircraft, disabling the running systems of most aircraft, approaching scenes, triaging victims and managing large incidents.

Instructor Bio: Cliff Cope began his fire service career as a Firefighter/EMT with the Mt. Washington Fire Protection District in 2002. One Day Classes

(8 hours each)

102: Fire Company Inspections Jim Juett

Thursday, October 3

This course is the first part of the Kentucky State Fire Marshal's Fire Inspector Program. This program will educate students on the new fire inspection program and the basics of being able to identify potential fire code issues as you conduct your company inspections. Students are encouraged to bring a tablet computer or laptop and calculator.

103: Trustee Class

Maurice A. Byrne, Jr., Attorney at Law Saturday, October 5

Board of Trustees of a Fire Protection District or Board of Directors of a Fire Department are charged with certain legal responsibilities, including: Fiscal Controls, Discipline Procedures, Control of Fire District, Chain of Command, Authority of Chief, Rights of Firefighters, and Liabilities. This year's Fire Legal Workshop will provide legal forms and sources for: Open Records New Laws & Regulations; New Fire Legislation & Proposals Affecting Fire Departments; Trustee Misapplication of Funds & Misconduct - Ethics Prosecution; eFIRE Legal Financial Calendars for October - November; Open Meeting New Laws & Regulations; County Judge/Mayor & Fiscal Court/Council Trustee Appointments Legal Authority; New Guns Laws & Cases Affecting Firefighters; together with other legal issues for KRS 75 Fire Districts and Chapter 273 Fire Departments will be discussed in this Fire Legal Workshop. An extended Question and Answer period will be conducted in the afternoon for as long as there are questions. Learn the laws that govern how Fire Departments must operate and discuss forms and procedures to conform to those laws. Legal forms and procedures will be distributed on a thumb drive to all registrants.



Instructor Bio: Maurice "Mo" Byrne has taught FIRE LEGAL WORKSHOPS for Boards of KRS 75 Fire Protection Districts and KRS 273 Fire Departments throughout the Western, Central, and Jefferson County areas, providing practical legal forms to avoid legal barriers. Since 1990, he has taught in Fire Commission Fire Schools throughout the State, with emphasis on practical legal solutions, checklist legal forms, legal questions & answers, and sharing experience from the 42 sections of eFIRE LEGAL HANDBOOK. Byrne formerly worked as Assistant Attorney General, Commonwealth Attorney, and County Attorney as a prosecutor and litigator. Mo was instrumental in the development and growth of the Kentucky Regional Fire Training Academy and has been involved in individual Fire Districts since 1983.

104: Fire Inspector II

Fire Marshals

Sunday, October 6

Prerequisite – Fire Inspector I certification

This class is the third step in the Fire Marshal's revised Inspector Certification program. This class is designed for the fire inspectors and building code officials that deal with life safety issues on a daily basis. The student will get detailed instruction on occupancy requirements and occupant loads. This class will consist of instruction followed by an exam. Students are encouraged to bring a table computer or laptop and calculator.

One Day Classes

(8 hours each)

105: CPR Instructor

Mike Will

Sunday, October 6
Maximum Class Size: 12

Become an American Heart Association CPR Instructor. Upon completion of this class, you will be able to train your firefighters and area citizens in CPR and AHA First Aid.

AHA now requires for you to do an online class prior to the Instructor Orientation class and that class is \$30 and is made payable to AHA thru the www.onlineaha.org website. You will need to complete the BLS Instructor Essentials prior to taking the class which is found on that website and then click on course catalog, scroll down to the BLS Instructor Essentials and launch/pay for the class thru that website. You will need to bring a copy of your completion certificate with you to class. You are taking the BLS instructor class so you will need to be BLS Provider certified prior to the class as well.....and bring a copy of your certification card.

106: Construction Class Safety for the First Responder Captain Mike Wallingford, Jeffersontown Fire Department

Saturday, October 4 or Sunday, October 6

"Tactical Change"

Rethinking your approach to construction emergencies

Driving through your district today you will see multiple construction sites varying in size. These sites pose risks to first responders because of the hazards within and we don't typically visit them unless there is an issue. In most cases an organization is not prepared for what lies beyond the construction entrance. Whether Industrial, Commercial or Residential they are all unique but share the same risks. This course is designed to exploit the major risks faced by the first responder as well as educate on the basic tasks being completed. We will cover Trenching/Excavation, Fall Protection, Confined Space and many more topics which are performed at jobsites in your district daily. These tasks may require a special response and these are issues that we need to address before an incident occurs. At the end of this course you will have the knowledge and confidence to return to your organization and readily prepare to plan and respond to incidents at a construction site.

The student will not need PPE and this course is open to all emergency responders.



Instructor Bio: Mike Wallingford Jr. is a Captain with Jeffersontown Fire and EMS currently assigned to a HazMat Engine. He is also an Environmental Health and Safety Specialists with Louisville Paving and Construction. Working in these two industries has helped Mike identify the need for further education in the fire service of the preplanning needs that construction sites pose.

201: Hard to Get Hours

Dwayne Davis, SFRT 6

Saturday, October 5 and Sunday, October 6

This class will satisfy the Kentucky State Required FC30000 Wildland Firefighting Awareness. This course is a product of portions from the S-130 Basic Wildland Firefighting and S-190 Wildland Fire Behavior Courses developed by the National Wildfire Coordinating Group, a Federal commission made up of state and federal agencies to set training objectives and standards for wildland firefighting in the U.S. It was designed to take on Kentucky uniqueness, looking at Kentucky specific qualities such as terrain, weather, fuels, tactics and suppression, as well as, wildfire tragedies that have occurred in Kentucky and other areas similar to Kentucky.

There is no required equipment for the students to bring.



Instructor Bio: Dwayne Davis begin his career in the fire service in 1989 as a volunteer firefighter with Garrard County District One. After spending several years with Danville Fire Department, he currently serves as Captain with the Shelbyville Fire Department. Dwayne is also adjunct instructor for SFRT Area 6. Dwayne has also had the pleasure of assisting Andy Starnes at Firehouse Expo.

202: NFA Arson 1

Major Matt Nelson, Training Coordinator, South Oldham Fire Department, SFRT 6
Saturday, October 5 and Sunday, October 6

This is the latest National Fire Academy course, "Arson Detection for the First Responder." This course will cover all the phases of fire investigation with emphasis on the firefighter's responsibility in arson detection. This class satisfies the requirements for the FRS 2074 in the KCTCS Fire/Rescue Science Associate Degree Program.

Students need to complete the pre-class assignment from the U.S. Fire Administration. The pre-class assignment is "Initial Fire Investigation for First Responders Q0379". The pre-class assignment is due the first day of class and students must bring a hard copy of the certificate of completion for the pre-class assignment to turn in to the instructor.




Instructor Bio: Matt Nelson has a Bachelor's of Science from Eastern Kentucky University in Fire Safety Engineering Technology with an emphasis in Fire, Arson, and Explosive Investigation. He also has an Associates in Applied Science from KCTCS. Published Author, Post Blast Scene Investigation by James T. Thurman. Certified Fire and Explosion Investigator, Certified Vehicle Fire Investigator, Certified Fire Investigator Instructor. Currently Employed at South Oldham Fire Department as the Training Coordinator and Chief of the Oldham County Fire Marshal's Office.

Class 203 – Incident Safety Officer Willard Tucker,

Saturday, October 5 and Sunday, October 6

This two-day course examines the Safety Officer's role at emergency responses. A specific focus on operations within an Incident Command System (ICS) as a Safety Officer is a main theme. Response to all-hazards types of situations will be emphasized.



Instructor Bio: An SFRT Area 6 Instructor, Tiger began his career in 1983 as a Volunteer at Bagdad Fire Department. He served over 25 years and retired as Chief from the City of Shelbyville Fire and Rescue. He currently serves as a a Sergeant for Anchorage/Middletown Fire and EMS.

204: Recruit Basic Major Shaun Carta, Highview Fire Department

Saturday, October 5 and Sunday, October 6

This is a hands-on class that will move students through multiple stations covering the following topics: Safety, Fire Behavior, Extinguishers, Personal Protective Equipment, Forcible Entry, Ventilation, Ropes and Knots, Hose/Nozzles/Appliances, Ladders, Salvage and Overhaul.

Equipment Needed: Full turn-out gear including SCBA No Facial hair that may impede the seal of your SCBA Mask allowed



Instructor Bio: Shaun Carta started his fire service career as a volunteer firefighter for the Highview Fire Protection District in 2004, and is currently working as a career Major of the Training Division for Highview. Shaun has a degree in computer technology and has extensive experience in commercial elevators. He is also a guest instructor at Texas A&M University teaching Structural Fire Fighting.

205 Auto Extrication Carlton Holbert, SFRT 6

Saturday, October 5 and Sunday, October 6

This class is designed to continue where the Basic Auto Extrication course left off. Knowledge of common techniques and tools is a prerequisite. The course will involve hands-on practical training involving various scenarios and address scene safety, evaluation and management. Hands-on experience using various methods to stabilize vehicles on their side, upside down, and on other vehicles or barriers is necessary. Operations will involve laying down, crouching, or crawling in vehicles. Includes challenging scenarios where all members of the team must be working to keep from pushing out of the golden hour.

Participants must furnish approved helmet, fire boots or leather safety boots, eye protection, gloves, coveralls or turnout gear for class.



Instructor Bio: Carlton Holbert is a Captain with Shelbyville Fire & Rescue. He has is been in the Fire service professionally for 20 years. Carlton is certified in several technical rescue disciplines and is a Level II fire Service Instructor. Carlton has been a SFRT 6 Instructor for 10 years.

206: \$130 Wildland

Saturday, October 5 and Sunday, October 6
Mike Schuerman, SFRT 6

This course is designed to provide entry level firefighters skills. Field time is encouraged, and many of the units are set up so they can be taught in either the classroom or the field. The field exercise for Unit 12 is required. A version of L-180, Human Factors on the Fireline, has been included as part of this course. Credit should be issued for both S-130 and L-180 upon completion of this course.

Objectives: • Explain what the LCES (Lookouts, Communications, Escape Routes, and Safety Zones) system is and how it relates to the Standard Firefighting Orders. • Construct fireline to required standards using various methods. • Strengthen, reinforce, and use holding actions on a fireline. • Extinguish the fire with or without the use of water. • Complete assigned tasks in a safe and efficient manner. • Given an assignment in a wildfire environment, describe factors in that environment which could impact safety.

Students shall have for practical skills: Long Sleeve Shirt, Long Pants, Helmet, Gloves, Sturdy Boots, Safety Glasses or Goggles Paper to take notes, pen or pencil for classroom.



Instructor Bio: Michael has had an interest in wildland firefighting after watching the Florida Division of Forestry extinguish a wildland fire near his home in Florida as a teenager. Michael attended his first wildland firefighting course in Indiana in 1991. Michael became a REDCARD Wildland Firefighter in 1993 after attending a 64 hour course in Indiana. His first employment was with the Indiana Department of Natural Resource Interagency Fire Crew in July 1994. He has been on assignments to Colorado, California, Montana, Indiana, Ohio, and Kentucky. Michael is currently a AD seasonal wildland firefighter for the U.S. Forest Service, Daniel Boone National Forest, Winchester Kentucky. Michael is also involved in Prescribe Fire Programs in Indiana and Kentucky. Mike is a member of the Kentucky Prescribe Fire Council training committee. Michael currently serves Jeffersontown Fire as a FFII/EMT since July 2004. Michael has been a Instructor for SFRT Area 6 since September 2017 specializing in Wildland Firefighting.

207: Safety & Survival

Saturday, October 5 and Sunday, October 6
Marc Myres, SFRT 6

This training will be presented in two parts. First day is Firefighter Survival (FC10000) focusing on basic survival actions to take when a firefighter is presented with worst case scenarios on the fire ground. Techniques taught are to provide individuals with the ability to perform actions that are not normally covered in convention training materials. Second day is Firefighter Rescue (FC20000) focusing on the rescue of downed firefighters on the fire ground. Techniques taught are all team based training responsible for the removal and extraction of individual firefighters that have found themselves in trouble and may not possess the ability to self-rescue.

Student Prerequisites: Students should have the recommended 20 hours of training before participating in this class. It is vital that students know how to properly don and doff PPE and SCBA prior to this class. This program is very physical in nature. It will demand high output of energy. Prior to taking this class it is strongly recommended that the department head of the agency ensures that participants are in good physical condition. Therefore, we recommend that all participants have a baseline medical surveillance to insure that they are in condition to do the required evaluations while wearing Self Contained Breathing Apparatus.



The student will need full PPE and SCBA for class.

Instructor Bio: Marc Myres started his career in the fire service 29 years ago as a firefighter. Today Marc is a Sergeant for Louisville Division of Fire and an Instructor for State Fire Rescue Training Area #6. He is also a Paramedic and a firefighter and a member of the Shelby County Fire Department.

208: Fire Inspector 1

Friday, October 4 and Saturday, October 5
Mike Allendorf, Fire Marshal, Okolona Fire Department
Prerequisite of Class 102 Fire Company Inspections

This class is the second step in the Fire Marshal's revised Inspector Certification program. This class is designed for fire professionals that perform fire prevention inspections on a daily basis. This class will provide instruction on the 2012 fire codes. Prior knowledge of dealing with inspections is required. This class will consist of two days of instruction followed by an exam. Students are encouraged to bring a table computer or laptop and calculator.

Prerequisite – Fire Company Inspections



Instructor Bio: Mike Allendorf, is the Fire Marshal for the Okolona Fire Department, since 2002. Mike joined the fire department in 1991 as a volunteer firefighter than was hired by the department in 1994. He has been a member of the Jefferson County Fire Inspectors Association since 1996 and has held various position within the organization over the years and currently is the Vice President, and helped form the Kentucky Fire Inspectors Association. He is also a member of various professional organizations such as NFPA, ICC, CAAK, and IAAI. Mike has an Associate Degree of Applied Science as well as a Bachelor of Science in Occupational Safety & Health. After the city/county merger in Jefferson County that occurred in 2003 Mike sat on a committee to help rewrite the local city ordinances that pertained to fire safety. Mike is currently the Chairperson for Louisville Metro Board of Zoning Adjustment (BOZA), and has been serving the past eight years on this board.

209: Supervision in Leadership: Frameworks to Success

Saturday, October 5 and Sunday, October 6
Carrie Blevins, Training Officer/Captain, SFRT 6

This two-day course provides the supervisor with the knowledge and skills to perform successfully in the fire and Emergency Medical Services environments. The course addresses professionalism, resilience, emotional intelligence, and situational awareness, as well as managing conflict, delegating mentoring, coaching, empowering, and building collaboration and synergy for professional growth.



Instructor Bio: Carrie Blevins joined the fire service in 2003 as Pleasure Ridge Park Fire Recruit, then she joined Fairdale Fire career staff in 2005. She is now currently the Training Officer/Captain.

210: Leadership in Supervision: Creating Environments for Professional Growth

Saturday, October 5 and Sunday, October 6

James Sohan, SFRT 6

This two-day course presents the supervisor with the basic leadership skills and tools needed to perform effectively in the fire and EMS environment. The course includes concepts related to a successful transition to supervisory and leadership roles, including concepts of adaptive leadership; change management; active followership; effective communication, including difficult conversations and advocacy-inquiry based dialogue; ethics; authority; power; decision-making; and active engagement through development of a personal plan.



Instructor Bio: Chief Jim Sohan began a lifetime in emergency services in 1983 with the Camp Taylor Fire Department, leaving as a Captain. In 1988, became a Police Officer with the Louisville Division of Police, retiring in 2011 as a Major. Jim was hired by the Louisville Metropolitan Sewer District in 2011 to work in their OSHA compliant department. In 2013, the Louisville International Airport was looking for a Chief that had experience in police, fire and emergency medical technician to manage a department of 53 personnel. Jim was hired into that position and is currently the Louisville International Airport Department of Public Safety's Chief. Jim is also a Volunteer Captain with the McMahan Fire Protection District.

211: Preparation for Initial Company Operations (PICO)

Saturday, October 5 and Sunday, October 6 Lennie Wheeler, SFRT Area 6

This course is designed to develop a better understanding of the roles and responsibilities of a Company Officer in preparing their company for incident operations. In addition, to clarify the transition from firefighter to company officer and the new roles relating to leadership and safety. This course is designed for company officers, acting company officers, or senior firefighters responsible for the management of a single fire company at an emergency incident. Those officers who are responsible for company readiness, personnel safety, and leadership as it relates to company operations.



Instructor Bio: Lennie W. Wheeler retired from the Louisville International Airport Fire Department as a Shift Commander and Training Officer. Lennie is currently the Fire Rescue Science Degree Program Coordinator/Instructor for the Jefferson Community Technical College/SFRT6 and is an IFSAC Level II Fire Service Instructor.

212: Engine & Truck Co. Ops 2.0 with Live Fire

Saturday, October 5 and Sunday, October 6
Pat Dalrymple
Max students 20

This is an updated version of our previous Engine and Truck Operations classes. It is a 2-day program with Engine functions with a RIT component and Truck functions with a RIT component. Individuals taking this program will be laying and operating charged hoselines, working with ground ladders, hand tools and power tools. There will be live fire, zero visibility smoke conditions and tight spaces which individuals will have to operate in.

<u>Prerequisites:</u> • No junior Firefighters (sorry) • No beards (put your facepiece on if there is hair touching the rubber seal you will not be allowed to participate) • Signed SFRT required release from your Chief stating you are trained to the minimum requirements for live fire training (form is attached)

Fire gear that meets NFPA requirements
SCBA that meets NFPA requirements
2 air bottles (1 for each day)
Positive attitude (you will work during this program)



Instructor Bio: Patrick Dalrymple, has worked as Engine firefighter, Engine Sergeant, Truck Sergeant, Engine Captain, Truck Captain, District Chief and Chief Training Officer with the Louisville Division of Fire over the last 22 years.

213: The First 5 Minutes: Tactical Considerations for the First-In Company

Saturday, October 5 and Sunday, October 6

Major Eric Duffy, Training Officer, Shepherdsville Fire, SFRT 6

Maximum Class Size: 11

The initial actions of the first-in company many times sets up the framework for the entire fireground experience from start to finish.

The goal of this 2-day class is to help prepare the Officer in making sound decisions, and to apply the needed tactical objectives for a safe and functional fireground operation. The first day we will cover the size-up process, decision making, command principles, and actions of the first-in Company. We will also use case studies of operations that resulted in both a functional and non-functional fireground.

The second day we will apply the principles covered in the classroom to practical scenarios using a residential building. Students will rotate into various positions for each scenario, including being the first-in Company Officer and commanding the scene.

Note: This class is geared for Company Officers and personnel that may ride in the Officer position. Full PPE including SCBA (with spare bottle) is required on day two for the practical scenarios.



Instructor Bio: Eric Duffy is a 33-year student/veteran of the fire service and is currently the Training Officer for the Shepherdsville Fire Department and an Instructor for State Fire Rescue Training Area-6. He retired as a Firefighter with the Lexington Fire Department, and as an Assistant Chief with the Pleasure Ridge Park Fire Department.

Full PPE is required including SCBA and a spare cylinder

401: Paramedic Refresher

Rick Robbins, SFRT 6

This refresher will cover the 30 hours of National Content required by the National Registry. We will also cover Pediatric Abusive Head Trauma. We will have presentations from Norton Stroke Team, Norton Children's Hospital Transport Team, and Jeremy Urekew.



Instructor Bio: Rick began his EMS career at 15 cleaning out horse stalls at the original Louisville EMS. He worked his way up to EMT, Paramedic, the Head of Education, then Major at Louisville Metro EMS. He worked at STATFLIGHT, SKYCARE, and the merged STATCARE, part-time Flight Medic for 15 years, and part-time for other local EMS services. He has been an EMS Educator since 1992. Rick also has served in the Military as a Combat Medic with the Reserves until he retired in 2001. While in the Reserves he provided education to other service members including Medics from other nations while deployed to Bosnia in 1994-1995 in a MASH Hospital assigned to the UN. On his last deployment, again in Bosnia in 2001, he organized, taught, and had a 100%, 6 students, in the first BTLS class in forward deployed units. Some students had to take classes via teleconference then came to his location to be. tested out. During that deployment he received two Army Commendation Medals for his actions in command functions and Education.
