# **Two Line Of Duty Deaths in February**

The fire service of Kentucky has lain to rest two brothers in one month. Last year we had two LODD for the whole year. Now we have had two in the same month. We can only hope and pray that we won't have another.

On February 17<sup>th</sup> Don Lamb Jr. 58, a forest ranger with the Kentucky Division of Forestry died from injuries he suffered from a September 7<sup>th</sup> incident involving a 12 acre wildfire in Livingston County. Lam was clearing a fire break for containment at the base of a bluff when a burning snag on top of the bluff broke loose and rolled off striking him from behind. The impact rendered Lam unconscious and seriously injured. After exhaustive efforts, physicians told Mr. Lam and his family in late January there was nothing more they could do — he would die from his injuries... it was just a matter of time. He was sent home in the care of his wife and hospice waiting until, in his words, "the Lord comes to get me." Lam is

survived by his wife Jeanie and his 16 year old Stepdaughter.



On February 24<sup>th</sup> Fire Chief Chris Stock of the Westport Fire Department died at his home after taking part in a training exercise earlier in the day. He volunteered with the Westport Fire Department



for 20 years and in his tenure as chief oversaw the building of a new fire station, recruited many volunteers and even found time to feed the birds. At Stock's funeral March 4, North Oldham Fire Chief Rick Albers said Stock jumped into action when he found a hummingbird "in dire straits." "He resuscitated this helpless creature, and followed up with the installation of a hummingbird feeder in the rafters of the fire station, "Albers said.

He is survived by his wife, Mandy, the department's assistant chief and a paramedic with Louisville Metro EMS, 5-year old twin sons and a 10-month old daughter.

# Treasurer's Notes by Terry Keller

Greetings from the Treasury. Sounds like a lead in from the I R S.

Hope everyone is getting ready for the spring and summer months. I have had enough snow and rain to last me a long time. OK, down to business. Dues have been coming in a little slow. There are 350 paid departments at this writing. There are 13 personal memberships. There are also, 13 sustaining memberships. Money from the vendors and sustaining membership are beginning to come in. Jamia takes care of this for the K F A, in conjunction with state fire school.

The budget for this year 2010-2011 was based on 400 paid departments and 16 personal memberships, with the income from professional fundraising in the amount of \$30,000.00. The total income will be very close to the budget that was pasted on the floor, at conference for the income this year.

I have met with John Wisemen, chairman of the finance committee, once every quarter to review the finances. The finance committee has met at K C T C S and reviewed the finances and felt there needed to be a few changes, due to fundraising income. One change was to eliminate the 800 fireline phone number. Another, was to curtail as much travel as possible to help balance the budget. These things are being done with out compromising any programs the K F A has.

The auto license plate issue has been resolved. Each firefighter can make a donation to the K F A when they renew their license plate. The K F A will receive \$10.00 for each firefighter license plate that is renewed. This could possibly bring in \$67,900.00 per year. What a shot in the financial balance for the K F A. The K F A has been asked to look into getting the same plate for a motorcycle. This is being followed up by trying to obtain 300 people who will pay a fee upfront so that the plates can be made. Ronnie Day is checking with the motorcycle clubs in the state to get this additional program up and running. Again, this would be a great financial boost to the income.

The Executive Board at the last meeting during the Green River Fire School voted to have all Executive Board members purchase a personal membership, to show their continuous support of the organization. This passed with everyone's support.

John Wiseman and I will be working on a proposed budget to present to his committee and the Executive Board at the upcoming State Fire School. If any committee chairman has an idea of what their committee will need as a part of their line item budget next year, please e-mail it to the treasurer. The Hall of Fame committee has turned in a budget for their request. The contract for the Newsletter and Web Page was approved at Green River and will be placed in the budget process. V F I S has been contacted for an estimate of Insurance cost next year. All this takes place to inform the membership of the best possible budget review for the next fiscal year 2011-2012.

Until I hear from some of the committee chairman or see some of you at fire school, stay safe and enjoy the spring days.

# International First Responder Seatbelt Pledge Buckle Up! So Everyone Goes Home®.

The International First Responder Seatbelt Pledge Program was originated to spotlight the heartbreaking loss of **Firefighter Brian Hunton**. Brian fell from the rear door of an Amarillo, Texas Quint as he was attempting to don his gear. He struck his head died two days later from his injuries. Brian was not wearing his seatbelt. Each year we continue to lose firefighters out doors and through windshields because they don't or won't simply buckle up. What a waste of a firefighter's life.

The seatbelt pledge was instituted several years ago in an effort to have firefighters commit to themselves that they will wear their seatbelts in emergency vehicles. The campaign has been a great success in some States...not so much in others. Unfortunately, in Kentucky, only six departments have taken the time to commit to the pledge. It's a

short list so we might as well recognize them: Frankfort, Hebron, Danville, Florence, Possich and Southgate. What about the other 600+ departments across the state. Well, here is your chance to make the commitment. I challenge the officers within every fire station in this state to get your department listed on the "Seatbelt Pledge" website as having taken the pledge. It's the right thing to do for your firefighters. Does this take a lot of time and effort? Not at all. Just follow these simple steps.

- 1. Visit the website: <u>www. EveryoneGoes</u> Home.com/seatbelts
- 2. Download the pledge.
- 3. Complete the pledge sheet, including Department name, address, authorizing name and signature, rank and contact email address.
- 4. Use as many sheets as necessary to collect signatures.
- 5. Once completed, please fax to 410-721-6213 or scan and send to seatbelts @EveryoneGoesHome.com
- 6. Once Pledge Sheets are received the website will be updated with the Department's information.
- 7. Information will be stored in the Program database.
- 8. The Compliance Certificate will be completed and sent to the State Advocate for distribution to the Department.
- 9. Contact with the Program staff and State Advocates will be made on a continuing basis for evaluation and recertification.

Each time you take the written test you must pay a \$15.00 charge. Contact Duane Suttles for more information about written test location and dates at 888-301-2946. REMINDER: Candidates must be at least 18 years of age and be a member of a Kentucky FD or a full-time student of Fire Science at EKU or KCTCS to be eligible for firefighter testing. Candidates must bring state issued drivers license or ID card to skills testing site for positive identification and verification of age eligibility. Candidates under 18, may complete any of the written exams, and may certify to Haz Mat Awareness only. All Certifications are based on the Professional Qualification standards set forth by the NFPA for Firefighters, except Haz Mat, which is a Job Performance standard. Our accreditation is through the International Fire Service Accreditation Congress (IFSAC).

### Line of Duty Deaths (LODD) for 2010

On average 100 firefighters are killed in the line of duty each year in the US. In 2010, 85 died in the line of duty between 1/1/2010 – 12/31/2010. Of that number 55 Volunteer (64.7%), 28 Career (32.9%),1 Wildland Full-Time (1.17%), 1 Paid-on-Call (1.17%).

The type of Incident they were responding to that took their life is as follows: 41 Not Incident Related (48.2%), 20 Structure Fires (23.5%) 8 Wildland (9.41%), 5 Other (5.88%), 3 Motor Vehicle Accidents (3.52%), 3 Rescue/Extrication (3.52%), 3 Unknown (3.52%), 1 EMS (1.17%), 1 Tech Rescue (1.17%).

Age of Firefighter When the Fatal Injury Was Sustained: **2 - Under 21**, 5 - 21 to 25, 4 - 26 to 30, 12 - 31 to 40, 16 - 41 to 50, 20 - 51 to 60, **25 - 61 and Over**, 1 – Unknown. The percentage of Firefighter Fatalities Under Age 40: 23.5%

In Kentucky last year we had 2 LODD. As of February 24<sup>th</sup> 2011 we have already had 2 LODD. Guys please be careful! Lets see if we can go the rest of the year without another LODD.

# Driving Impaired... It's Just Not Worth It By Dave Dennison

The National Highway Traffic Safety Administration reports that in 2009 there were 5,505,000 police reported motor vehicle traffic crashes in the United States. That's right 5 million times in 2009 alone we were reminded just how dangerous driving could be. In those crashes we lost 30,797 people and injured another 1,517,000. That means there were 11.01 deaths and 722 injuries for every 100,000 people in this country. I don't know about you, but those numbers should make you shutter just a little bit every time you get behind the steering wheel of a vehicle.

As emergency responders we increase the odds even more by adding lights, sirens and using specific exemptions as allowed to us by most state laws. We are allowed to exceed the speed limit, pass through controlled intersections and travel against traffic patterns. The downside however is that these exemptions greatly increase our odds of being in a collision. There are over 15,000 emergency vehicle accidents in the US each year and deaths while responding to and returning from alarms continues to be the second leading cause of line of duty deaths.

Studies also show us that in 2009, of the persons who were killed in traffic crashes, a staggering 32% died in alcohol impaired crashes. This number does not even consider the other accidents that involved drivers impaired from drugs, lack of sleep, age or physical impairments. Where would these numbers be if we considered all of those factors as well? The Unsafe Driving Acts study tells us that human factors contributed to 99.2% of motor vehicle accidents, environmental factors contributed in only 5.4% of the crashes and vehicle factors only contributed in .5% of those events. We always tend to blame something else, but the numbers show that 99.2% of the time, we are the ones to blame.

I remember that while at Cornell University my statistics class was at 11am. This was just before lunch and my biggest concern most days was what the sandwich of the day at The Big Red Barn was going to be. I do recall an interesting conversation in one class however about the term *causality*. It was defined as the relationship between an event (the cause) and a second event (the effect), where the second event is understood as a consequence of

the first. I remember how those numbers could get pretty crazy in a hurry and thinking how the heck that information would ever be useful to me in the real world.

As I look at the numbers above I have to wonder if this is what causality was all about. Take a dangerous task (driving) add in a danger factor (emergency operations) and then add a second factor (driving impaired) and watch how these numbers spin out of control. I am sure someone that paid more attention in stats will contact me to dispute my theory here, but I think you can understand the point I am trying to make. The numbers do not look good if we drive an emergency vehicle with any type of impairment.

Before you get behind the wheel of an emergency vehicle with any type of impairment please ask yourself the following questions. What is the risk of driving this vehicle? Can I afford to lose my license or my job? Is this worth risking my life, my partner's life or a member of the general public's life? What happens to the original call if we fail to complete our mission because of my actions? What happens to my reputation and the reputation of my organization when we are involved in a crash because of my impairment? Am I ready to become just another number like all of those above?

So next time that alarm comes in right after you just had that beer with dinner, or took the cold medicine or you haven't slept in 24 hours, stop and think. Is what I am doing or about to do really worth it? We all joined this service because we want to help save lives and protect property. Are you willing to risk it all and possibly take a life or destroy property? **Driving Impaired – It's just not worth it.**

## 2011 Legislative Session By Howdy Kurtsinger



This legislative year was the annual short session, as in the past there was more political debate than working for the good of the Commonwealth. There were many pieces of legislation that affected the fire service. This year there were a total of 168 Senate Bills, 259 Senate Resolutions, 494 House Bills and 229 House resolutions introduced during the legislative session. That totals 1,150 documents to consider. Less than 100 of these pieces of legislation passed and because of the discussion over who is going to be governor many items did not pass or were even seriously considered.

There were 36 of the bills introduced that went on the KFA legislative watch list for the fire service and many issues are issues that we opposed. There were two bills that wanted to change incentive pay and state aid; neither received a hearing. The budget office requested that we wait for another year because of the economy and to see if our funds are more stable. We would like to look in the future at the possibility of increasing the incentive and state aid if funding is available.

Fireworks legislation has been an issue for the past three years and during this year we have been able to bring in all the different groups that are affected to put together legislation that we hope will be better for the protection of our firefighters. There were issues that we required in the legislation. Current Kentucky law is completely ineffective and has little or no enforcement capability. An example is in the Louisville metropolitan area where no police officer has responded to a fireworks complaint in the last ten years! Further, Kentucky is surrounded by three states that aggressively market fireworks, Tennessee, Ohio and Indiana. Local vendors of compliant fireworks do a booming business in "bootleg" fireworks every year (pun intended). Surrounding states fireworks vendors advertise on Kentucky TV stations in the weeks preceding the 4th of July! The reality is the fireworks issue in Kentucky is out of control and getting worse not better. When a legislator stands up on the floor of the Kentucky House and brags about purchasing several thousand dollars' worth of fireworks every year you get an idea of what we face. House Bill 333 which passed does indeed permit "consumer fireworks" to be sold in Kentucky. However, it also does two

important things. 1. It specifically permits local jurisdictions to pass local ordinances controlling fireworks. In a "mini-max" state where local jurisdictions seldom are permitted to enforce more stringent fire safety ordinances than minimum state law this is a tool for our local authorities to use. 2. It also has direct reporting to the local jurisdictions of quantities and location of fireworks storage. Just knowing who is dealing in fireworks in a local community is going to be helpful. In short, the ball is firmly in the court of the local fire official, something that seldom happens in this state. Some jurisdictions have already begun the process of passing local ordinances; others are adopting a wait and see approach. Regardless, we are seeing activity on this issue like nothing we have seen for many years. If local jurisdictions are successful in controlling the problem we may see some progress at the State level after all. Stranger things have happened! We at the local level have bragged for years that we could do it better. It's time to put our money where our mouth is! I invite you to check back with me in a couple of years. We'll either have a classic example of locals showing the State a better way or we'll be as bad as Tennessee, Ohio and Indiana.

The last issue that I would like to discuss is the pension changes that were proposed in Senate Bill 2. In Senate Bill 2 the defined benefit plan would have been closed and the new members to a fire department would be placed into a defined contribution plan. This would mean that we would have firefighters working side by side who are working under four different pension plans. Not only is this not fair to the current firefighters that have made changes in their pension plans, but it could be the main issue that causes recruitment problems in the future. Also the additional cost associated with the closing of the current funding from new member would be a great burden on all local government for the next 15 years. We also testified that changing the benefits over the past years have not been given a chance to work to see if the effect to the system could have been enough to make the Kentucky Retirement System in better financial shape. During this session many issues affecting the fire service should have been discussed but most of those bills are just put in to make people feel good about an "effort legislators are making" and are never considered as serious pieces of legislation.



# Virginia's Elite Rescue Task Force 1 Has Arrived in Coastal Japan.

Seventy-four members of Virginia Task Force 1 have been arriving by helicopter into a mountainous region 100 miles north of Sendai, to help rescue victims of the disastrous tsunamai that hit Japan March 11.

The VATF-1 team will be conducting rescue operations around the seaport of Ofunato. Battalion Chief Michael Schaff told NBC 4 in a phone interview that rural villages in region's valleys have been swamped by mudslides and high water.

Weather in the mountainous area is cold, and snow has been falling.

The team carries with it a heavy package of rescue equipment, including inflatable boats and rescue canines. Paramedics, structural engineers, and technical rescue specialists are all part of the Virginian unit.

The task force flew into Misawa Air Base on Sunday March 13<sup>th</sup>. On the way to Japan, the team was joined by a West Coast rescue crew, California Task Force 2. Both American units will be operating under the command of Tokyo Fire Department.

On Monday, Japanese officials reported that over 1,000 bodies had washed ashore along the Miyagi prefecture.

The team will make their base of operations in Ofunato, a fishing hub with a population of 40,000. The town was hit by a tsunamai once before in 1960.


