Robert Bryant Stiles

Bryant was born December 5, 1956 in Owensboro, Kentucky to Robert Louis and Mary Edwina Tanner Stiles, and was married to the former Cherie Ann Gilmore on February 10, 1979.

Bryant received his Business Degree from Kentucky Wesleyan College, was the Director

of State Fire Rescue Training and Homeland Security exercise program, earlier worked as a loan officer at the former Cardinal Federal Bank in Owensboro, and attended Calhoun Baptist Church. He joined the McLean County Central District Fire Department in 1974, served as the Fire Chief, and was currently serving as the Assistant Fire Chief. Bryant was a member of the Kentucky Firefighters Association, served as the treasurer, was a member of the National Volunteer Fire Council, served on committees with the National Fire Protection Association, was a member of the North America Fire Training Directors Association, and was inducted on July 31, 2012 into the Kentucky Firefighters Association Hall of Fame. He loved his family and enjoyed spending time with both them and his friends.

Survivors include his wife of 33 years, Cherie Stiles; two daughters, Christin Brown and husband, Thomas of Livermore and Hannah Stiles of Calhoun; a grandson, Clay Thomas Brown; his parents, Bobby and Edwina Stiles of Calhoun; and a brother, Michael Stiles and wife, Kim of Rumsey.

The above obiturary tells very little of who Bryant Stiles really was. Bryant was a very close friend of mine and he was critical to the fire service of Kentucky. The picture to the right was taken the night Bryant received his induction to the KFA Hall of Fame. He was so very proud of that honor. He had a vision of where the fire service of Kentucky should go and would let nothing stand in his way to achieve that goal. His actual accomplishments are too numerous to mention but surfice it to say he lived and breathed the Kentucky Fire Service. We have lost an irreplacable advocate. He shall be missed. Notes From The President's Desk Sam Stacy

The KFA Executive Board is working hard for all the firefighters of the Commonwealth of Kentucky. We held our annual Fall Executive Board meeting during the Buffalo Trace Fire School on the campus of Maysville Community College on October 27, 2012. A lot of the directors and committees have been very busy working on projects since the conference in July and a lot of work is still to be completed.

During the fall meeting several important items were discussed. Howdy Kurtsinger updated everyone present on the legislative efforts going on in Frankfort especially the committee looking into the pension reform. The committee looking into pension reform has meeting scheduled for November and then again in December to vote on recommendations that will be sent on to the full House and Senate to be considered in next year's General Assemblies session. Please keep up with this process as it moves along because it affects a large number of not only firefighters but numerous other groups as well. Howdy and Gerald will be sending out more informational emails after these meetings to keep you inform as to what actions we need to take to help in this process.

Another subject that come up during the financial report was that we have incurred an approximately \$9,000 shortfall in revenue from the license plate sale this year. The Kentucky Transportation Cabinet informed us that all proceeds from these sales were down this year for one reason or another. The \$9,000 will have to be accounted for in one form or fashion to get the budget back into alignment. I along with the Executive Board would encourage each of you to promote the usage of the KFA license plate and if you or anyone from your department doesn't have a KFA license plate now go out and get one for your vehicle. The KFA stands to gain \$10 for each firefighter plate that is on vehicles in the Commonwealth of Kentucky.

Those are just two of the issues that were discussed during the fall meeting, and I encourage all of you to look at the minutes from the meeting to see all the subjects discussed. Better

yet I encourage each and every one of you to attend these meetings and have an input into the business of the Kentucky Firefighters Association.

The KFA will be having its next Executive Board meeting in Lexington on February 23, 2013 at 9am during the Kentucky Officers School hosted by the Green River Firefighters Association. I would personally invite each and every one of you to come out and participate in the meeting and enjoy one of the finest fire schools the Commonwealth of Kentucky has to offer. I especially would like to see all the KFA Directors there to participate in the business of the Kentucky Firefighters Association. The Director's job is to participate in the business and then to take it back to each association to let them know what is going on in the KFA. The KFA is only as strong as the local associations and we encourage you to come out and let your voices be heard.

We are quickly approaching the Christmas Holiday season and my family and I would like to wish each and every one of you a Merry Christmas and a Happy New Year. Let us not forget all the military men and women out there in harm's way this year and say a special prayer for their safety and speedy return home. Most importantly let us all not forget the true reason behind this glorious season. NFPA's Commitment to the Fire Service: Key NFPA Goals

In the last edition of Smoke Signals II, I introduced myself and NFPA and wrote briefly about NFPA's fire-service-driven leadership. In this edition I would like to specifically address key NFPA goals that provide value to the fire service.

Home Fire Sprinklers

NFPA's number one goal is supporting the adoption of home fire sprinklers in new one and two family homes. NFPA has put its full force of resources to work supporting the adoption of sprinkler regulations/ordinances/statutes and working to defeat anti-sprinkler efforts. When it comes to sprinklers, even if the regulation/legislation is in the form of the International Code Council's residential code, NFPA will put its time, talent and resources behind supporting the adoption. We will continue to support pro-sprinkler activities and fight anti-sprinkler campaigns throughout the United States, Canada and beyond.

NFPA co-founded and chairs the Home Fire Sprinkler Coalition (HFSC). The HFSC's mission is to educate all stakeholders about the importance of home fire sprinklers.

NFPA founded and funds the Fire Sprinkler Initiative (FSI). The FSI supports sprinkler adoptions by providing the fire service and other advocates with extensive resources, including numerous, comprehensive studies and reports covering topics such as installation cost, economic development, water usage, environmental impact (green), water meters, trade ups, and more. All of these reports are free to anyone with an interest in fire and life safety through its website www. firesprinklerinitiative.org.

The NFPA "Faces of Fire" campaign, designed to put a face on the life-saving impact of home sprinklers, was initially funded through a USFA grant. This campaign features real people telling personal stories to demonstrate the need for sprinklers. This year the grant was no longer funded; however, NFPA picked up the full cost to continue this important program.

On April 2-3, 2012, NFPA sponsored the inau-

gural Fire Sprinkler Summit. Representatives from throughout the U.S. and Canada came together in Chicago to share ideas and learn from the group's collective experiences. Chief Jack Reckner and Rick Daugherty represented the Kentucky Fire Service.

In addition to our headquarters' staff, NFPA employs two, full-time sprinkler field experts (Tim Travers & Jeff Hudson) along with Maria Figueroa who provides research and communications support.

Fire Safe Cigarettes

After decades of unsuccessful attempts to pass federal legislation to save lives and prevent injuries from cigarette-ignited fires, NFPA championed a state-by-state campaign to get model legislation adopted. Working with the fire service and other advocates, legislation was passed in all 50 states. According to the most recent NFPA report, civilian deaths attributed to smoking material fires in the United States in 2010 were at or near an all-time-low. The Kentucky Fire Service played a key role in making what was a dream for decades a reality in every state in the U.S.

Wildland Fire Initiative

NFPA has created a new Wildland Fire Operations Division (WFOD), which includes a full-time staff of eight and six part-time contractors. In fall 2011 NFPA opened a new WFOD office in Denver. The WFOD partners with designated state forestry liaisons in 45 states.

The WFOD goals include:

- expanding the reach of the Firewise Communities/USA recognition program to more neighborhoods (currently over 800 communities in 40 states)
- promoting principles that lead to Fire Adapted Communities – where all entities take part in wildfire prevention and mitigation
- providing clear information and messaging to the public on how wildfire behaves, what individual homeowners can do, and the effectiveness of those actions;
- obtaining better information and data on what the wildfire problem really is in terms of property and life loss and injury;
- facilitating the use of GIS mapping by local communities and states to help identify hazard

areas in the Wildland Urban Interface (WUI);

- promoting the adoption of standards and ordinances that address land use and building construction in the WUI;
- providing training tools for the fire service and others to conduct comprehensive property risk assessments for homes in the WUI and providing educational information pertaining to what owners can do to mitigate wildland fires; and,
- identifying ways to empower and engage the volunteer fire service in the WUI issue.

Also, NFPA is now the administrative lead of the Fire Adapted Communities program that joins numerous stakeholders around the concept of wildfire mitigation for the whole community – all entities taking part in fire prevention, planning and mitigation.

As I hope you will agree, NFPA walks the talk when it comes to supporting and serving the fire service! In my next article I will discuss NFPA codes and standards and AHJ training and support programs.

Written testing information is available on the Ky IFSAC testing web site at http://www.kyffcert. com. Tests are given at the system office usually on the third Monday of the month. Each time you take the written test you must pay a \$15.00 charge. Contact Duane Suttles for more information about written test location and dates at 888-301-2946. REMINDER: Candidates must be at least 18 years of age and be a member of a Kentucky FD or a fulltime student of Fire Science at EKU or KCTCS to be eligible for firefighter testing. Candidates must bring state issued drivers license or ID card to skills testing site for positive identification and verification of age eligibility. Candidates under 18, may complete any of the written exams, and may certify to Haz Mat Awareness only. All Certifications are based on the Professional Qualification standards set forth by the NFPA for Firefighters, except Haz Mat, which is a Job Performance standard. Our accreditation is through the International Fire Service Accreditation Congress (IFSAC).

I have lost a very close friend, Bryant Stiles, and I shall miss him. I have put together a few thoughts. They are a little lengthy but my heart is heavy with thoughts of my friend. If you have the time read them if not it's OK I just wanted to share.

I considered Bryant one of my closest friends. Our friendship began the day of his interview for a job with State Fire Rescue Training.

It was funny and he has shared this story many times. When he sat down for the interview he said to himself that he knew the number of votes he had before the interview began. He named the people on the interview committee and when he came to me he said "I knew I had your vote". I said "Bryant I didn't vote for you". His mouth dropped to the floor he was astonished. I laugh about it now just thinking about it. He always made me

laugh.

Soon after we started working together I told him a joke about two boys talking about a puppy. I am sure most of you have heard it "MR Puppies". He laughed about the joke and after that I got the name "Mr Puppies" from Bryant, he always called me that.

The first big event he attended as a coordinator was the 1991 KFA Conference in Lexington. Cherie (Bryant's wife) had come just for the banquet Tuesday and when she walked up Bryant introduced her to me and I said "Bryant she is pretty she not homely like you told me". I still laugh when I think about the look on his face. He was always so serious and we made a great team. Our director at that time was Bill Hankinson and when he was up talking I taped a ribbon on his back without him knowing and Bryant told me a few days later that Cherie said "These guys are nothing like the group at the bank are they".

We traveled a lot together. We took several trips to Emmetsburg Maryland, Singer Island Florida, Columbia South Carolina and many more. You can't be in a car with someone for that long of a time without getting to know that person well. He loved his family and he loved the fire service. One time coming back from Emmetsburg we were talking about the 3 new trucks that State Fire Rescue had purchased and I knew how touchy a subject they were with him. But someone had to say it so I did. I said "Bryant what if one of the other coordinators wants the truck and trailer for a couple of weeks to do training". He said "I will take the trailer up to him but he is not getting the truck". I said "Well what if he needs to move the trailer to different locations during that time". He said "HE IS NOT GETTING THE TRUCK"!!! I said "Bryant that isn't your personal truck it belongs to all of us". We had just passed Ashland on our way home. He pulled the van over to the side of I64 and said GET OUT! We laughed about that for years because about a week after we got home he got a call from Kyle Reagan asking to get the truck and burn trailer for a couple of weeks because he had several departments that needed

I remember once I took a vacation to Gulf Shores AL for a week with in-laws and family. When I got back Bryant and I had a trip somewhere and during that trip I said "Bryant, I spent a week with family and I have to say they are not near as much fun to be around". He reminded me of that several times over the next few years. On our trip to Singer Island FL we were between sessions sitting at the hotel grill restaurant on the beach when we looked out over the beach. What looked like, a beautiful young well built thing walked along the beach with her back to us. We both made some comments and then she turned around. Much to our surprise she was a he with beard and all. I think both our faces turned red. I said to Bryant what is that he is wearing? He said it's a Thong. I said "I thought that was something you wear in a shower on your feet." We both laughed for a long time over that incident.

I remember spending time with Bryant, Charlie and Jamia over a meal with Bryant's favorite Thanksgiving/Christmas meal of Honey Ham and all the fixins in Campbellsville. There was a time when Bryant, Charlie and I were inseparable. Once after a fire school in Bowling Green while my daughter Rachel was in college at WKU we took her out to eat. Bryant and Charlie could be a little challenging to a waitress. My daughter said she would never go out to eat with the three of us again because we embarrassed her.

During a legislative year Bryant and I would meet in Caneyville (it's about half way between Etown and Owensboro) for breakfast usually on Mondays to swap out trailers and keep each other abreast of what was happening with the Green River Firefighters and Dixie Firefighters. If I could set the clock back I would if for no other reason than to spend more time with friends like Bryant.

I will never forget Bryant. It is like I have lost a brother. Bryant was family to me. The Kentucky Fire Service has lost an advocate the likes of which I doubt they will find again anytime soon. I will continue to keep the Stiles family in my prayers. I love you guys. Woody

NEW LAW REQUIRES ADDITIONAL TESTING FOR ALL CAREER KENTUCKY FIREFIGHTER CANDIDATES

Versailles, KY – Beginning <u>January 1, 2013</u>, all career firefighter candidates will be required to undergo a physical abilty test.

The candidate physical ability test (CPAT) will be designed to assess a candidates' ability to handle the physical demands of fighting fires and shall include exercises that stimulate the most common tasks involved in fire suppression.

Exercises for the CPAT will include, but are not limited to: stair climbing, hose drag, equipment carry, ladder raise and extension, forcible entry, search, rescue, ceiling breach, and pull.

The Kentucky Fire Commission will charge a fee of \$125 for all out-of-state firefighter candidates participating in the CPAT. In-state participants will not be required to pay a fee.

I am very happy to announce that the CTBS program has received funding for another year. As you are probably aware, programs such as these are fading fast, so it is extremely important that you take advantage of them while they are here. Use the CTBS programs to teach firefighter health and safety within your region, within your county and most importantly within your department. The National Fallen Firefighters Foundation's "Everyone Goes Home Program" has had some major changes, most specifically to "Courage to Be Safe." Now all CTBS information can be accessed from one website: http://ctbs.everyonegoeshome.com/. Want to find a class? Want to take a class on line? Want to become a CTBS Instructor? All this and many other resources are now available with the touch of a button. It doesn't get much easier than this and I encourage you to make sure that every member of your department is aware of this site and if you are in a position to do so, have all of your firefighters take the CTBS class.

Over the last several years the fire service has seen some meaningful decreases in the number of firefighters killed in the line of duty. As of November 7th, of this year, there were 67 reported LODD. I believe that a major reason for this decrease is our attempts to better train our people in health and safety. Cyber Theft and Smart Phones

Senior Risk Management Consultant Emergency Services Insurance Program We've all heard so much about Cyber Theft and how important it is to secure the information on our computers, but what about your cell phone? Today's "Smartphones" make it easy for you to store a great deal of information which is vital to your life as well as your organization yet many times these phones are not treated with the same care as computers. A recent research study conducted by Javelin Research indicated that smartphone users are 33% more likely to become a victim of identity theft than non-users. That same study found that 62% of smartphone users do not use password protection allowing anyone who finds or steals their phone to have access to its contents.

Smartphones often contain sensitive information such as addresses and phone numbers, passwords, account numbers, email, voice mail, and vital information pertaining to your organization. Some of this information could be devastating to your department if it falls into the wrong hands.

Your Smartphone should be password protected or locked though a pattern code. If it is lost or stolen this could make the difference in allowing someone to see all of your information stored on the device. Read your owner's manual to learn how to properly lock your phone and treat the password as you would any other.

Next, be wary of apps you may download. Apps may be designed to track your location, read owner data, modify or delete your SD card content, and otherwise read or change stored information. Before downloading an app, make certain you know what it can and will do. Review the information about the app and what permissions you grant.

At some point in time you may want to upgrade your phone, but then what do you do with the old one? There are many options for unwanted cell phones such as recycling, donating, reselling, or simply disposing. But what about your information? You wouldn't just throw out a laptop computer without wiping the hard drive clean, but many people don't think twice about their smartphones. Simply deactivating the phone does not remove vital information.

Before disposing the phone remove the subscriber identity module (SIM) card. Even with this card removed however you will most likely have to do more to erase all of the sensitive data from the device. You can seek assistance from the owner's manual for the phone or from your service provider. Manufacturers' websites also sometimes provide this information.



KFA Legislative Report

Since the last meeting I have been asked as to explain if possible what all the



information is that I have sent out to the fire service. I will make an attempt but this is not the final decision, and I think as I stated when we began that we will not known until December. We will have to be on our toes through the upcoming legislative session and try to protect as much of the benefits we have enjoyed in the past as possible. I know that we have sent out tons of information to many of you or you received it through other sources but I didn't want to keep anything from anyone. Because I wanted everybody to see the amount of information that we must read during the time this issue is being discussed. Also I want to make sure that everyone had the chance to be more informed on the issue to talk to you Legislator.

I have set through the hearings and the Pew Group has recommended that changes be made to the pension system that will affect all members of the system in some way. I think we are down to the following changes;

- Closing the funding gap
 - 1. Changing the contribution schedule
 - 2. Suspending the cost-of-living adjustment
 - 3. Issuing bonds
 - 4. Changing the contribution policies
 - 5. Taxing retirement benefits
- · Options for a New retirement system
 - 1. Kentucky needs a new retirement system that is affordable, sustainable and secure.
 - 2. The current system's costs are neither transparent nor predictable.
 - 3. The current system is heavily back loaded, meaning that workers that change careers will not be put on path towards a secure retirement.
 - 4. Both the cash balance and stacked hybrid plan could provide a retirement benefit comparable with the Tier3, share risk between employees and taxpayers, and put workers that switch careers on a secure path to retirement.
 - 5. Cash balance and hybrid plans both have transparent and predicable cost.
 - 6. It is important that the task force either pick one of these plans or identify an alternative approach to ensure that benefits being offered to future workers can provide retirement security while remaining affordable to Kentucky taxpayers.

To explain what this means is that everyone in the system, retired, active and future firefighters will see changes in the current system. For retirees there will not be a cost of living adjustment until the system reaches some level of funding. The reason that I say some level is because that has yet to be determined by this committee but I look for nothing less than 80% funding and that will not happen for a very long time or never! For active members they will see their contribution increase by as much as 2%. For future employees the system is about to change to a new system one that will not pay benefits as much as members receive today and having members work longer.

We must wait until the next Pension Task Force meeting before we have the final answer to what the future for firefighters and public employees is going to look like, but it will mean less for all! I have also been asked about and have posted to the news section of the KFA Website (www.kyfa.org) a copy of the KACO's plan that would set up another board and the issues that they have raised. I can't take position for or against their plan because we have to wait until we see what the Task Force comes up with. We have to do what is best for the firefighters and those affected by the changes. I can report that the KPFF through the IAFF are at this time doing an actuary analysis and will be informing us of the best options for the future firefighters.

I hope that this information helps and we will be trying to keep everyone up to date on the information as we receive it. If you have questions please feel free to contact me.

Remember when the Legislature goes into session in Juanuary we may need YOU to contact your local legislator in a hurry. You can find your legislator at http://www.lrc.state.ky.us/Legislators.htm. Become familiar with those that represent you. Talk to them and let them know you care and are concerned about Kentucky's future. We will post information on the website just as soon as it is available. Check it often! Get involved!



Division of Forestry Tests New Forest Fire Reporting System Lynn True 11/9/12

As fall forest fire season comes

to an end, fire management staff with the Kentucky Division of Forestry (KDF) will be busy assessing the effectiveness of a new internal reporting system that allows employees to identify and map forest fires in 'real time'. The web-based reporting system, officially titled the Kentucky Forest Fire Reporting System, not only allows KDF dispatchers to enter new forest fires

as they are reported, it enables all KDF employees to quickly access useful maps and daily fire conditions.

"Wildfire reporting helps assess wildland fire issues such as the location of the fire, the cause, the number of acres involved and the status of suppression efforts," said Steve Kull, Assistant Director for KDF. "We still have a few procedural bugs to work out, but being able to evaluate our wildfire suppression efforts as fires occur will enable the division to better protect life and property."

"The new system will not only increase the efficiency of collecting and reporting the most up-to-date information about wildfires, it will be a useful tool in determining fire suppression efforts," said Kull. "The various layers of the maps allow our personnel to assess terrain, slope, roads and other critical factors in fighting wildland fire."

Prior to the new reporting system, it was difficult for KDF employees to keep current on all the fires occurring across the state. Collecting information about current forest fire activity often involved numerous phone calls and e-mails between the Frankfort office and the district offices. Furthermore, relaying accurate information to the media and the public was often compromised during times of heavy fire activity.

"From a fire manager's perspective, this is an incredible tool that will allow our agency to receive updates on fire threats as they are occurring," said Luke Saunier, KDF's Fire Management Chief. "Now we can look at the fire activity across the state and see exactly where our resources are needed the most."

The concept for developing the system was initiated by Roy Boggs, KDF Geoprocessing Specialist and Tony Sturgill, Geoprocessor Principal for the Division of Information Services (DIS). Marvin Terry, DIS Information Systems Manager, developed the application through Microsoft SharePoint.

A map seen below in the new Forest Fire Reporting System shows fire activity in southeast Kentucky.

LOSAP, The Vol. Emergency Services Recruitment and Retention tax issue legislation, The Volunteer Responder Incentive Protection Act has bipartisan support, The US Fire Administration Reauthorization Act has been passed, Public Safety Officers benefit changes now have support from all fire organizations, Volunteer Fire Assistance / Rural Fire Assistance has been suffering declines in funding and the NVFC is trying to keep the assistance up. The NVFC is working with other organizations to get the Medicare Reimbursement add-on payments extended. MedPAC recently announced they should expire. The NVFC supports the Emergency Responders Volunteer Efforts that would allow a \$1000.00 tax credit to active members of volunteer fire departments.

I have attended two important meetings recently. One dealt with Community Para-medicine. This program is no longer a point of discussion but reality. There were fourteen different programs presented. I came away feeling there is great opportunity for those who embrace this program.

At the second meeting I represented the NVFC who is a member of a special "Coalition" that is attempting to improve the availability of medications to protect emergency responders. Thousands of dollars of drugs are being discarded every day that are still effective and could be used to protect

emergency responders from various chemical and health issues. A representative from a drug company made a statement that expiration dates on medicines is a misnomer in that they have some drugs stored since 1936 that are still very effective. The group is prepared to present its position to congress.

A few items of interest:

Ventlab is recalling their manual resuscitators as they may not be providing enough air through the inlet valve. If you are using one of these, contact the company.

The National Counter Terrorism Center has released a document regarding IED targeting of emergency responders

November 15th is Rural Health Day. You may want to conduct some public information programs on that day.
